DECLARATION OF CONFORMITY OF MATERIALS AND ARTICLES INTENDED TO COME IN CONTACT WITH FOOD

FACEM spa declares that the materials it mainly uses do not contain the monomer Bisphenol A. Where, for technological reasons, it is not possible to eliminate this monomer, it is monitored closely to guarantee the presence falls within the limits set by law. This control is guaranteed by an established in-house Quality System, which involves periodic transfer tests, in accordance with criteria and frequencies established by law.

Currently, Bisphenol A is only found in products called “Slicers”.

FACEM S.p.a. also declares that the products it markets and intended to come into contact with food are manufactured in compliance with the following European and Italian regulations:

- EU Regulation 1935/2004 *on materials and articles intended to come into contact with food*;
- EU Regulation 2023/2006 *on good manufacturing practice (GMP) of materials and articles intended to come into contact with food*;
- Italian Ministerial Decree of 21/03/1973 and subsequent updates and modifications *which governs the control procedures of products intended to come into contact with food by means of transfer tests*.

Lastly, FACEM S.p.a. declares that even the following regulations have been complied with, where required and depending on the material used, for some parts intended to come into contact with food (MOCA):

- EU Regulation No. 10 of 14/01/11 *(Plastic materials and articles intended to come into contact with food)*;
- Italian Ministerial Decree No. 76 of 18/04/07 *(Aluminium and aluminum alloys intended to come into contact with food)*;
- Italian Ministerial Decree of 11/11/2013 *(List of stainless steel suitable for food contact)*;
- Italian Ministerial Decree no. 243 of 01/06/88 *(Chrome strip and painted articles intended to come into contact with food)*;
- Italian Ministerial Decree of 18 February 1984 *(Tinplate welded containers intended to come into contact with food)*;
- Italian Ministerial Decree of 04 April 1985 *(Ceramic articles intended to come into contact with food)*.

The transfer tests on MOCA are carried out in an external certified chemical laboratory as often as indicated in the FACEM Quality Management System and under the supervision of the TiFQ certifying body.
